FOR THE YEAR UNDER REVIEW, THE GROUP RECORDED AN INCREASE IN OPERATING REVENUE FROM US\$5.6 MILLION IN 1998 TO US\$5.9 MILLION FOR 1999. THE GROUP'S OPERATING PROFIT BEFORE EXCEPTIONAL ITEMS WAS US\$3.8 MILLION AS COMPARED TO US\$4.1 MILLION FOR THE CORRESPONDING YEAR. THE DECREASE IN OPERATING PROFIT BEFORE EXCEPTIONAL ITEMS WAS DUE MAINLY TO LOWER CONTRIBUTION FROM INVESTMENT RELATED ACTIVITIES.
