FOR THE PERIOD UNDER REVIEW, THE GROUP REVENUE INCREASED FROM US\$3.3 MILLION IN 2002 TO US\$3.8 MILLION IN 2003. CONSEQUENTLY, THE GROUP RECORDED A PROFIT FROM OPERATIONS OF US\$2.8 MILLION AS COMPARED TO US\$2.3 MILLION IN THE PREVIOUS YEAR CORRESPONDING PERIOD.

THE INCREASE IN REVENUE AND PROFIT FROM OPERATIONS WAS MAINLY DUE TO LEISURE AND HOSPITALITY ACTIVITIES AND HIGHER INTEREST EARNED FROM INVESTMENT ACTIVITIES.
