THE DIRECTORS OF GENTING INTERNATIONAL P.L.C. ARE PLEASED TO ANNOUNCE THE UNAUDITED RESULTS OF THE GROUP FOR THE HALF-YEAR ENDED 30 JUNE 2004, TOGETHER WITH THE COMPARATIVE RESULTS FOR THE HALF-YEAR ENDED 30 JUNE 2003 AS FOLLOWS:

FOR THE PERIOD UNDER REVIEW, THE GROUP'S REVENUE INCREASED FROM US\$3.8 MILLION IN 2003 TO US\$4.4 MILLION IN 2004. THE GROUP RECORDED A PROFIT FROM OPERATIONS OF US\$7.2 MILLION AS COMPARED TO US\$2.8 MILLION IN THE PREVIOUS YEAR CORRESPONDING PERIOD.

THE INCREASE IN REVENUE WAS MAINLY DUE TO LEISURE AND HOSPITALITY ACTIVITIES. THE INCREASE IN PROFIT FROM OPERATIONS WAS MAINLY DUE TO UNREALISED FAIR VALUE GAINS ON QUOTED INVESTMENTS.

FOR THE PERIOD UNDER REVIEW, THE GROUP HAS RECORDED UNREALISED FAIR VALUE GAINS ON QUOTED INVESTMENTS AMOUNTING TO US\$4,548,000. HOWEVER, FOR THE PERIOD BETWEEN 1 JULY 2004 AND 20 AUGUST 2004, THE GROUP HAS UNREALISED FAIR VALUE LOSSES ON QUOTED INVESTMENTS OF US\$4,069,000, THUS GIVING NET UNREALISED FAIR VALUE GAINS OF US\$479,000 FOR THE PERIOD BETWEEN 1 JANUARY 2004 AND 20 AUGUST 2004.

BARRING UNFORESEEN CIRCUMSTANCES, THE DIRECTORS ARE OF THE OPINION THAT THE GROUP'S RESULTS ARE EXPECTED TO BE SATISFACTORY FOR THE SECOND HALF-YEAR.
