ANNOUNCEMENT

The Board of Directors of Genting International P.L.C. (the "Company") is pleased to announce that as at 29 November 2007, Palomino Limited, a wholly-owned subsidiary of the Company has acquired 9.38% of the total issued and paid-up share capital of Rank Group plc, a company listed on the London Stock Exchange ("Share Acquisition").

Rank Group plc is the second largest bingo and the second largest casino operator in the United Kingdom and it also operates on-line gaming.

The Share Acquisition is financed from internally generated funds as well as S\$71.2 million from the net proceeds of the Rights Issue which was completed on 18 September 2007 following the listing and quotation of the Rights Shares on the official list of the Singapore Exchange Securities Trading Limited.

The Share Acquisition is not expected to have any material impact on the consolidated net tangible assets and earnings per share of the Company for the financial year ending 31 December 2007.

None of the Directors or substantial shareholders of the Company has any interest, direct or indirect in above Share Acquisition.
