Genting International PLC changes name to Genting Singapore PLC

Singapore, 29 April 2009 – Genting International P.L.C. today announced that it has changed its name from “Genting International Public Limited Company” to “**Genting Singapore PLC**”, with effect from 27 April 2009. The company also announced that it has been de-registered under the Isle of Man Companies Acts 1931 to 2004 and re-registered as a company governed under the Isle of Man Companies Act 2006 with company number 003846V, with effect from 28 April 2009.

The application process of the name change began after the approval was received from its shareholders at the company’s Extraordinary General Meeting in Singapore on 24th April 2009.

Mr. Justin Tan Wah Joo, Managing Director of Genting Singapore PLC commented, “I am pleased that we have completed our name change, which is timely to reflect the Company’s primary country of listing, investment and operation. We are making the necessary changes to reflect our new corporate name. Our corporate website has been changed from www.gentinginternational.com to www.gentingsingapore.com. All references and materials relating to Genting International PLC will progressively be changed to Genting Singapore PLC.”
