On account of Tan Sri Lim Kok Thay being a beneficiary of the discretionary trust, he is deemed interested in the Genting Singapore PLC shares by virtue of the deemed interest of Parkview Management Sdn Bhd as trustee of the discretionary trust. Parkview Management Sdn Bhd is owned by Amaline (MD) Sdn Bhd, Puan Sri Lim (nee Lee) Kim Hua, Tan Sri Lim Kok Thay, Mr Yap Chong Chew, Ms Roselind Niap Kam Lian and Mr Gerard Lim Ewe Keng, each holding one share respectively. The board members of Parkview Management Sdn Bhd are Puan Sri Lim (nee Lee) Kim Hua, Tan Sri Lim Kok Thay and Dato' Joseph Lai Khee Sin.
