**ANNOUNCEMENT ON STRIKING OFF A JOINTLY CONTROLLED ENTITY**

---

The Board of Directors of Genting Singapore PLC (the "**Company**") wishes to announce that Mark Burnett Productions Asia Pte. Ltd. ("**MBPA**"), its 50% owned jointly controlled entity which had ceased operations in 2010, has applied to be struck off from the Register of Companies under Section 344 of the Companies Act, Cap. 50 ("**Transaction**"), and the process is expected to be completed by 13 April 2012. Accordingly, MBPA will cease to be a 50% owned jointly controlled entity of the Company after that date.

The Transaction is not expected to have any material impact on the consolidated net tangible assets and earnings per share of the Company for the financial year ending 31 December 2012.

Mr. Tan Hee Teck, Director/President and Chief Operating Officer of the Company, is also a director of MBPA.

Save as disclosed above, none of the Directors or substantial shareholders of the Company, has any interests in the above Transaction other than through their respective shareholdings in the Company.
