NOTES

- In view of the Covid-19 health concerns, the Postponed Fifty-Third Annual General Meeting ("Postponed 53rd AGM") will be held on a virtual basis through live streaming and online remote voting using Remote Participation and Voting Facilities ("RPV"). The Company has appointed Tricor Investor & Issuing House Services Sdn Bhd ("Tricor") as the Poll Administrator for the Postponed 53rd AGM to facilitate the RPV via TIIH Online website at <https://tiih.online>. Please follow the procedures set out in the Administrative Guide for Postponed 53rd AGM which is available on the Company's website at <https://www.genting.com/agm/> to register, participate, speak and vote remotely via the RPV.
- The Broadcast Venue of the Postponed 53rd AGM is strictly for the purpose of complying with Section 327(2) of the Companies Act 2016 which stipulates that the Chairman shall be at the main venue of the Postponed 53rd AGM. Members will not be allowed to attend the Postponed 53rd AGM in person at the Broadcast Venue on the day of the Postponed 53rd AGM.
- A member who is entitled to attend, participate, speak and vote at the Postponed 53rd AGM via the RPV is entitled to appoint a proxy or in the case of a corporation, to appoint a duly authorised representative to attend, participate, speak and vote in his/her/its place. Where a member appoints more than one (1) proxy, the appointments shall be invalid unless the member specifies the proportions of his/her/its shareholding to be represented by each proxy. A proxy need not be a member of the Company. There shall be no restriction as to the qualification of the proxy. In the case of a corporation, the Proxy Form for Postponed 53rd AGM must be either under seal or signed by a duly authorised officer or attorney.
- Where a member of the Company is an exempt authorised nominee which holds ordinary shares in the Company for multiple beneficial owners in one (1) securities account ("Omnibus Account"), there is no limit to the number of proxies which the exempt authorised nominee may appoint in respect of each Omnibus Account it holds. The appointment of two (2) or more proxies in respect of any particular Omnibus Account shall be invalid unless the exempt authorised nominee specifies the proportion of its shareholdings to be represented by each proxy. An exempt authorised nominee refers to an authorised nominee defined under the Securities Industry (Central Depositories) Act 1991 ("SICDA") which is exempted from compliance with the provisions of subsection 25A(1) of SICDA.
- The appointment of a proxy may be made in a hard copy form or by electronic means. Proxy Forms for Postponed 53rd AGM must be submitted in the following manner, not less than forty-eight (48) hours before the time appointed for holding the Postponed 53rd AGM or at any adjournment thereof:

IMPORTANT NOTES

- The Proxy Form for Postponed 53rd AGM DOES NOT INVALIDATE the proxy form which was circulated together with the Notice of 53rd AGM dated 7 April 2021 ("**Original Proxy Form**"). All Original Proxy Forms deposited with Tricor not less than forty-eight (48) hours before the time appointed for holding the meeting or any adjournment thereof shall remain valid and acceptable.
 - Subject to the appointer being a member who is entitled to attend the Postponed 53rd AGM, the Original Proxy Form that has been deposited with Tricor shall remain valid unless a Proxy Form for Postponed 53rd AGM superseding the previous deposited Original Proxy Form (if any) is deposited with Tricor.
 - For the purpose of determining members who shall be entitled to attend the Postponed 53rd AGM, the Company shall be requesting Bursa Malaysia Depository Sdn Bhd to issue a Record of Depositors as at 15 September 2021. Only depositors whose names appear on the Record of Depositors as at 15 September 2021 shall be entitled to attend the said meeting or appoint proxies to attend and vote on their behalf. For the avoidance of doubt, the Original Proxy Form received from any member whose name is not on the Record of Depositors as at 15 September 2021 shall be deemed null and void.
- Pursuant to Paragraph 8.29A(1) of the Main Market Listing Requirements of Bursa Malaysia Securities Berhad, all resolutions set out in the Notice of Postponed 53rd AGM will be put to vote by poll.
